

Club Horse Terms of Use

Earning Club Horse Points

To ensure you receive credit for your Club Horse transactions, please be sure to log in to your account when you visit Horsechannel.com. Club Horse Members may track their summary online at www.horsechannel.com or by subscribing to receive the Club Horse eSummary(sm). Club Horse eSummary subscribers receive their summary and information every month, regardless of activity level. Your summary includes points earned, along with newsletters and special promotions.

If your account has no qualifying activity in any 30-day period, all points in the account will expire.. Qualifying activity is defined as redeeming any Club Horse award or accruing points on any eligible Club Horse activity.

Points will be credited only to the account of the Club Horse member. Points will be credited within 24 hours of accruals of the points.

Except as otherwise explained below, Club Horse points are not transferable and may not be combined among Club Horse members, their estates, successors and assigns. Accrued points and awards do not constitute property of the member. Neither accrued points, nor awards are transferable by the member (i) upon death, (ii) as part of a domestic relations matter, or (iii) otherwise by operation of law

Club Horse points are determined by the activity you participate in and the points are explicitly stated at the point of participation.

Only individual persons are eligible for Club Horse program membership. Corporations or other entities are not eligible to become Club Horse members or to accrue Club Horse points. Only the member named on the account will be entitled to access account information.

If your account has no qualifying activity in any 3-month period, all points in the account will expire. Qualifying activity is defined as redeeming any Club Horse award or accruing points on any eligible Club Horse activity.

Points will be credited only to the account of the Club Horse member. Points will be credited within 24 hours of accruals of the points.

Points are redeemable for one account per person. You may have multiple pet profiles, but creating multiple accounts is not allowed.

This means that the accumulation of points does not entitle members to any vested rights with respect to such accumulated points, awards or program benefits. In accumulating points or awards, members may not rely upon the continued availability of any award or award level, and members may not be able to obtain all offered awards. Any award may be withdrawn or subject to increased points requirements or new restrictions at any time. Horsechannel.com may, among other things, (i) withdraw, limit, modify, or cancel any award; (ii) change program benefits, participant affiliations, conditions of participation, rules for earning, redeeming, retaining or forfeiting points, or rules for the use of points Horsechannel.com reserves the right to end the Club Horse program with 30 days notice. Horsechannel.com may amend its rules of the Program at any time without



notice. Once points are redeemed for awards, all transactions are final. There are not any returns or exchanges allowed. Income tax liability on Club Horse awards, if any, is the responsibility of the member.

General Club Horse Conditions

At no time may Club Horse points be purchased, sold or bartered. Any such points are void if transferred for cash or other consideration. Violators may be liable for damages and litigation costs, including Horsechannel.com attorneys fees incurred in enforcing this rule.

Horsechannel.com reserves the right to audit any and all accounts at any time and without notice to the member to ensure compliance with Club Horse program rules and applicable conditions. In the event that an audit reveals discrepancies or violations, the processing of Club Horse awards, points accrual and summaries may be delayed until the discrepancies or violations are resolved satisfactorily to Horsechannel.com. Pending such resolution, members may be prohibited from redeeming points for a Club Horse award in Horsechannel.com's sole discretion.

If Horsechannel.com and/or any Club Horse participant improperly denies a member points credit, awards, or some other benefit, the member's exclusive remedy shall be the issuance of the improperly denied credit, award or benefit if available, or such other alternative comparable benefit as determined by Horsechannel.com, which shall have no additional liability whatsoever.
